Object, competition rules

The Audi quattro Ski Cup (event) is a ski race organized by AMAG Automobil- and Motoren AG. The participants of the Audi quattro Ski Cup ski on a slope equipped with gates, start and finish posts. The ski race is held as a giant slalom event. The skiing time per run depends on the course setting and route.

The participant

- assures that he has sufficient skiing skills to participate (see separate declaration of the participant on risks and liability),
- is not to endanger himself or others and is to observe the general FIS rules of conduct for skiers and all other laws and regulations during participation and
- undertakes to wear a helmet for security reasons throughout the sporting part of the event and
- to comply with the orders and instructions of AMAG, its agents, the organisers, the staff of participating ski schools, the mountain rescue or mountain railway.

In addition to these terms and conditions of participation, the attached rules also apply. The rules for the contest can be adapted or modified at any time by AMAG.

The ski race is held by AMAG at its own discretion. There is no right to participation in or continuation of the ski race. The rules for the contest can be adapted or modified at any time by AMAG. The ski race can be fully or partially terminated or the implementation changed at any time, in particular due to weather conditions. AMAG may exclude the participant from participation without giving reasons, in particular in case of violation of these conditions.

Prizes

Within the framework of the event, prizes can be won in several categories. The rules communicated at the venue or with regard to a specific prize have priority of application. The evaluation of the race times and the awarding of the prizes are at the discretion of AMAG. Successful participation in the competition does not entitle the participant to a prize. All decisions are final.

In case of a win, AMAG is authorised to use the contact information of the participant for delivery of the prize. If a delivery fails there or the contact data prove to be false, the winner forfeits any claim to the prize and AMAG is entitled to give the prize to another participant.

Declaration of the participant on risks and liability

The participant is fully aware of the risks associated with participating in a ski race. He knows and accepts that when participating in a ski race, damage to his health, or in severe cases his life, may occur and that the main risk factors include his own behaviour on the racecourse, such as his own speed, and external factors such as environmental conditions, technical equipment, atmospheric conditions, or natural or artificial obstacles. He also knows that participating in a ski race requires the full exertion of his physical and mental abilities. The participant knows that several of these risk factors cannot always be foreseen and controlled and therefore avoided or prevented through safety measures.

The participant knows that his behaviour on the racecourse or other public courses can endanger other participants and third parties.

The participant therefore assures that he masters the sporting requirements of the Audi quattro Ski Cup to such a degree that he neither endangers himself nor others and that he is physically and medically fit for this sporting challenge. The minimum requirement is the safe command of red slopes.

The participant takes part in the event at his own risk. He is to inspect the racecourse. He is responsible for the selection of suitable equipment and its condition, for the speed at which he completes the race and the choice of lane on the racecourse. He acknowledges that AMAG is not responsible for the inspection or monitoring of his equipment or his skiing style.

Any claims by the participant for damages or compensation asserted against AMAG, the owners, operators of the site and the buildings and structures on or within which the event takes place, are excluded. This does not include damage arising from injury to life, limb or health, if AMAG, the owners, operators of the site and the buildings and structures on or within which the event takes place, are responsible for the breach of duty, and other compensation claims based on an intentional or grossly negligent breach of duty by AMAG, the owner, operator of the site and the buildings and structures on or within which the event takes place. This limitation of liability applies equally to the respective representatives, organs and agents of the beneficiaries.

Rights to use images and details of the participant

The participant consents to the reproduction, distribution and other use of all photographs, video and/or sound recordings of the participant (hereinafter: recordings) taken directly by AMAG or by a third party during the event, in particular during the preparation for the race, the award ceremony and winners' celebration, for all kinds of commercial purposes. In particular, AMAG may use the recordings with further information about the participants in all media in order to draw attention to the event, the participants, happenings and results or to use these in advertising.

AMAG is, in particular, granted the spatially and materially unrestricted, worldwide and non-lifetime-limited, exclusive, unremunerated right to exploit and publicly reproduce the recordings for the purpose of product and corporate advertising and corporate communication. AMAG is entitled to copy, to publish and to distribute the recordings on any medium, in any amount and size, itself or through third parties, especially in print media such as flyers, advertisements, posters or newspapers. The consent covers any public reproduction, including the transmission or disclosure to the public, in particular on free TV, pay TV, video-on-demand or other digital media such as the Internet, Intranet, on social media platforms or on CD-ROM, DVD, or similar media. Furthermore, in so far as the participant provides AMAG with this information within the context of the event, the participant grants AMAG permission to use his name, his age and professional career and the results and happenings of the event to the temporally, spatially and materially unrestricted extent described above.

AMAG is permitted to change and process the images or combine them with other images or components at will provided that the person undersigned is not defaced or presented in an unreasonable context. AMAG is not to use the recordings for improper purposes and is to respect the dignity of the person photographed.

The rights granted to AMAG pursuant to the above three paragraphs shall also be granted to the same extent to AUDI AG, Ingolstadt, Germany, and the customer-partner of AUDI AG in the country of residence of the participant (if the latter is not resident in Switzerland).

AMAG shall be entitled to transfer the revocable or irrevocable rights transferred and/or granted to third parties either in part or as whole and to grant the latter exclusive or non-exclusive rights of use or exploitation of such rights and/or permit the further transfer of same.

In the interest of fairness and to keep the event as a race for amateurs, certain groups of people are not permitted to compete. AMAG therefore requests that you confirm the following:

- have not completed any ski or snowboard instructor training courses (of any level) and**
- do not appear on an FIS or national points list.**
